

**Summary Notes-December 4, 2012**

**Welcome and Introduction:**

CAB member Marolyn Parson opened the meeting by welcoming everyone and reminded them of the meeting rules. She then asked everyone to introduce themselves, including online attendees. Next, each committee member and individual in attendance introduced himself or herself. CAB member Parson continued with her update by listing the Facilities Disposition & Site Remediation (FD&SR) members along with the committee's focus. CAB member Parson provided an update of the committee's recommendations, stating recommendation 279 is open and recommendations 283, 293, and 294 are pending.

CAB member Parson introduced Mr. Brian Hennessey, DOE-SR, who discussed "Federal Facility Agreement Appendix E."

**Presentation: Federal Facility Agreement Appendix E-Brian Hennessey, DOE-SR**

Mr. Hennessey's purpose for his presentation was to provide information discussed in response to the Citizen's Advisory Board's (CAB) Recommendation 279, Federal Facility Agreement (FFA) Update Provided Annually. He provided a brief introduction of the FFA Appendix E

including cleanup milestones for SRS waste sites. He provided diagrams, which allowed him to show the revision and submittal process and milestones found within Appendix E. Mr. Hennessey then gave a status overview of FY 2013 FFA Appendix E and milestones for FY 2014 and 2015. He then provided information showing the major changes that will be included within the FY 2013 FFA Appendix E.

**Discussion: Environmental Monitoring in Georgia- Gail Whitney, DOE-SR**

Ms. Whitney began her discussion by displaying the 2012 Monitoring Chart, which listed the different types of monitoring conducted in both Georgia and South Carolina. She listed several locations, types of wildlife, and natural resources being monitored by Plant Vogle, SRS, and South Carolina Department of Health and Environmental Control (SCDHEC).

She mentioned that SRS is attempting to evaluate maps in order to better depict and explain the monitoring situation in Georgia. She stated that information will possibly be added within the environmental summary report that concentrates on exactly on the type of environmental monitoring conducted in different communities.

**Committee Discussion:**

CAB member Parson addressed the DOE response to recommendations 294 and the DOE response to a CAB letter written to address a previous DOE response to recommendation 283. Both are posted on the website.

CAB member Parson adjourned the FD&SR Committee meeting.
