Point of Contact Status Update: Zach Todd, DOE-SR Mr. Todd reviewed the Point of Contact projects.

Presentation: SRNS Workforce: Carol Berry, SRNS

Ms. Berry gave a comprehensive overview of the current workforce data for SRNS.
