

**Summary Notes–April 22, 2014
SRS Citizens Advisory Board
Strategic & Legacy Management Committee Meeting**

The Savannah River Site (SRS) Citizens Advisory Board (CAB) Strategic & Legacy Management (S&LM) Committee held a meeting on Tuesday, April 22, 2014, from 4:30-6:20 p.m., at the Department of Energy (DOE) Meeting Center in Aiken, SC. It was also streamed online via Google Hangouts.

The purpose of this meeting was to receive a presentation on the Environmental Management (EM) cleanup program performance measures targets for fiscal year (FY) 2014. There was also time set aside for committee discussion and public comments.

Welcome and Introduction:

CAB member Clint Nangle welcomed everyone, and stated the meeting was being streamed online. He then asked everyone to introduce themselves. He discussed the committee's focus, and provided a brief recommendation status update, stating recommendation 318 was open. CAB member Nangle introduced Mr. Rich Olsen, Department of Energy-Savannah River (DOE-SR), to begin his presentation.

Presentation: Environmental Management Cleanup Program Performance Measures Targets for Fiscal Year 2014 – Rich Olsen, DOE-SR

Mr. Olsen said the purpose of his presentation was to fulfill a 2014 S&LM Work Plan topic by providing a fiscal year (FY) 2014 targets and year-to-date actuals for Environmental Management (EM) performance metrics. He provided background information for the Cleanup Program at the SRS and explained the current lifecycle estimate indicated EM cleanup would be completed by year 2042. He stated the performance metrics were developed to track progress towards end state targets. He discussed the four major areas for the SRS Cleanup Program, which included Radioactive Liquid Waste, Solid Waste, Nuclear Materials, and Soil, Groundwater, and Facilities. He explained that under each major cleanup area were different individual metrics. Mr. Olsen provided several pictures of activities categorized under each major cleanup area. He reviewed a chart that showed the overall EM Performance Report through February 2014 and individual reports for each major cleanup area. He stated DOE-SR would continue to track and monitor performance measures for key operational areas of EM cleanup operations. You can view this presentation on the CAB website at: cab.srs.gov

Committee Discussion:

CAB member Nangle explained it was time for the S&LM Committee to discuss the SRS Integrated Priority List for FY 2016. CAB member Bob Doerr said he felt High Level Waste should remain a top priority and suggested adding two additional statements about how the incident at WIPP and funding levels were impacting SRS.

Public Comment:

Crissy Waller, DOE-SR, was asked by CAB member Nangle to share updates about the Young Generation program at SRS. Ms. Waller mentioned the group recently began working on drafting a mission statement. She also said at the last meeting the group decided to begin exploring external outreach opportunities to educate the public about the positive impact SRS provides local communities. She said she would plan to attend the next S&LM Committee meeting in order to brief the committee of the progress with the formulation of the mission statement.

CAB member Nangle adjourned the S&LM Committee meeting.
