EM Site-Specific Advisory Board Chairs Meeting Update

• Topic: On January 27, 2014, the Savannah River Site (SRS) Citizens Advisory Board (CAB) adopted Recommendation 317:

To fund an Independent Environmental Monitoring Program in the State of Georgia EM Site-Specific Advisory Board Chairs Meeting Update

• Recommendation to the DOE-SR:

Initiate conversation with the State of Georgia for the purpose of funding an environmental monitoring program similar to the Environmental Surveillance and Oversight Program funded in South Carolina.

# The Department of Energy (DOE) SR Response:

• The DOE Savannah River Operations Office does not accept your recommendation.

• However, in recognition of the expressed concerns of the CAB, and the citizens of Georgia, the DOE-SR proposes to request an evaluation by the University of Georgia's Savannah River Ecology Laboratory (SREL).

### Communications Recommendations by SREL

- While the DOE-SR disseminates information to a wide variety of stakeholders in both South Carolina and Georgia,
- The information provided is largely technical in nature and assumes that the individuals receiving this information have the ability to interpret the data and draw conclusions regarding health risk.

### Communications Recommendations by SREL cont.

• For this reason, and considering the concerns of local community members about radiological health risks, SREL recommends that DOE-SR takes the following actions relative to the public outreach and education program:

## Communications Recommendations by SREL cont.

 Consider developing a strategy that incorporates limited monitoring data as a basis for providing outreach and education that can help local residents draw their own conclusions concerning health risks.

# EM Site-Specific Advisory Board Chairs Meeting cont.

 SREL has engaged Georgia Women's Action for New Direction (WAND) to assist them with providing sound, scientifically-based education and outreach on radionuclide monitoring programs and risk associated with radionuclides in the environment to local communities in Georgia.

# EM Site-Specific Advisory Board Chairs Meeting cont.

#### • Accomplishment/Activity: Student Liaison Program.

- Dr. Hopson, Chair A&O Committee is currently working to develop a Student Liaison Program.
- The committee held a conference call with the CAB Chair, CAB Support Team and Ms. Mindy Mets (SRS-CRO) to discuss ideas for the program. Mindy also invited the CAB and the CAB Support Team to participate in a STEM Career Connection Day on October 22, 2015.

WIPP Status Update

 Initial focus will be on emplacement of wastes generated during recovery activities and emplacement of wastes currently stored in the WIPP surface facilities (these wastes were received but not emplaced prior to the events).

# WIPP Status Update cont.

- The timing for resumption of shipments from offsite, currently is uncertain and will be based on a variety of factors:
  - WIPP transportation and waste acceptance capabilities.
  - > Generator sites compliance commitments.
  - Storage capacities, and other site specific technical or safety issues.

#### WIPP Status Update cont.

- Interim and supplemental ventilation system will be completed in early 2016.
- Complete Operational Readiness Reviews by WIPP, and DOE must be completed before an operational date is determined.
- He also informed us that Construction of additional surface storage at WIPP is one option being considered for temporary storage.
