- Every two years a sitting Board member must reapply for an additional term
- Members are term limited to 3 terms, or 6 total years
- In years past that limitation did not exist so some members served for more that 6 years

Facilities Disposition and Site Remediation Committee

The Facilities Disposition and Site Remediation Committee addresses the remediation of contaminated soil, groundwater, and surface water. The Facilities Disposition and Site Remediation Committee deals with issues related to the Federal Facility Agreement, risk management/assessment, the regulatory process, and other cross-cutting issues pertaining to environmental restoration. The Facilities Disposition and Site Remediation Committee also follows deactivation and decommissioning actions taken to reduce risk and costs following shutdown of excess industrial, radioactive, and nuclear facilities. Nuclear Materials Committee

The Nuclear Materials Committee was established to study issues that involve nuclear materials (generally uranium and plutonium) that have an impact on present or future Savannah River Site activities. Issues include used nuclear fuel program activities (foreign and domestic), nuclear materials management, and nuclear materials integration. The Nuclear Materials Committee addresses consolidation, storage, and disposition issues related to legacy materials that were once part of the nuclear weapons production cycle. The Nuclear Materials Committee also studies issues related to the receipt and storage of foreign research reactor spent nuclear fuel. Waste Management Committee



The Waste Management Committee reviews the management, treatment, storage and disposition of radioactive wastes, including transuranic waste, low-level waste, mixed low-level waste and radioactive liquid waste and provides advice and recommendations to the Savannah River Site on these activities. Principal goals of the Waste Management Committee are: to see (1) a trend of reduction in risk to the public, workers, and the environment posed by these wastes, and (2) integrated and comprehensive system approaches used in weighing Savannah River Site waste management and disposition options. Savannah River National Lab

- Lab opened a base in Hanford to support the Pacific Northwest National Laboratory
- Activities at Hanford includes looking at tank waste chemical vapor issues and, work at the vitrification facility
- Chance to exchange ideas and engage in laboratory-wide discussions

Clean-Up Goals

- Government Accountability Office's risk report identifies operations vulnerable to potential inefficiency, fraud and abuse. Environmental liabilities stemming from contaminated properties new to this list this.
- In 1994, GAO recommended that Congress require agencies to report their plans to complete site inventories and clean-up costs by amending the Comprehensive Environmental Response, Compensation, and Liability Act.
- GAO found DOE EM lacking in giving Congress complete information about cleanup obligations, which may affect congressional appropriations for cleanup activities.

Clean-Up Goals - Continued

 In FY 2016, GAO estimated government's environmental liabilities at ~\$447 billion, an increase from \$212 billion in 1997.

BOARD

- DOE holds 83% of this estimated \$447 billion of government's liability, mostly related to nuclear waste cleanup.
- As of 2016, half of DOE's environmental liability held at two locations—Hanford Site and Savannah River Site. Both sites on Environmental Protection Agency's National Priorities List.
- In a statement from the Senate Committee on Energy and Natural Resources, a Senate aide said inadequate short-term funding will only increase long-term cleanup costs.

Online Meetings

- Online meetings recently discussed in CAB Survey and Standard Operating Procedures, and this update is just for thought and comparison for SRS CAB.
- Energy Department, Environmental Protection Agency, and Washington state Department of Ecology held four State of the Site meetings last year in Washington and Oregon. This year, one meeting will take place only online, in hopes of attracting a more national audience.
- Meetings billed as "opportunity for public to discuss cleanup progress, challenges, and priorities with decision-makers."



Online Meetings - Continued

Hanford Advisory Board implored the three agencies to stop the webinar-only approach. "While webinars are excellent tools for sharing information, they do not best serve a two-way conversation or provide meaningful opportunities for the public to influence cleanup decisions," Hudson wrote in a letter to the agencies on the board's behalf.



TRU Waste and WIPP

- CAB Recommendation 209 asked DOE to accelerate TRU Waste Drum Shipments to WIPP
- WIPP temporarily unable to accept shipments since a Feb 2014 fire, however, a new report by DOE developed estimates for the resumption of TRU Waste.
- Oak Ridge and SRS will be able to ship to WIPP this year
