Rick Perry



- Congressional delegation members, including U.S. Rep. Joe Wilson, R-S.C., along with Georgia congressmen, penned letter to Mr. Perry inviting him to visit the site "at your earliest convenience."
- Perry was confirmed as Secretary of Energy in March.
- Former Texas governor holds the position previously held by former President Barack Obama appointee, Ernest Moniz.
- The letter is signed by Wilson, U.S. Reps. Jeff Duncan, Trey Gowdy, Tom Rice and U.S. Rep. Jim Clyburn, D-S.C.
- Republican Georgia U.S. Reps. Rick Allen, Jody Hice, Barry Loudermilk, Austin Scott and Drew Ferguson also signed onto the letter.

Rick Perry

 In the letter, representatives write SRS has been "one of the primary economic engines of the CSRA," providing more than 10,000 "high paying jobs and millions of dollars in tax revenue for the surrounding communities."







WIPP

- Transuranic Waste shipment left SRS for first time in three years to WIPP near Carlsbad, NM.
- WIPP had been closed since 2014 after a truck fire in the underground mines.
- WIPP is a deep geological repository, dug into the salt basin deep beneath the desert floor. The salt will naturally collapse in over time, encapsulated and isolating the waste from human exposure.

WIPP

- This is the first of eight shipments planned for SRS in 2017.
- WIPP anticipates receiving two shipments weekly, ramping up to four shipments a week by the end of 2017.
- Shipping eligibility based on generator sites verifying TRU waste meets requirements for safe transportation and disposal. Exact shipping schedule may fluctuate based on emplacement rate at WIPP and logistics.

Hanford - Tunnel Collapse

- Workers noticed that a section of the tunnel had caved in Tuesday morning.
- The tunnel, which is made of wood and concrete and covered in 8 feet of soil, was constructed during the Cold War to hold rail cars loaded with equipment that had been contaminated in the process of plutonium production. It has been sealed since the mid-1990s.
- Pending Legal Case Court Ordered for Clean-Up to begin by 2020



Hanford - Tunnel Collapse



- DOE can provide overview of information that has been released by the Richland Operations Office. SRS analysts are not subject matter experts regarding design and safety bases associated with the affected Hanford facility and we are not receiving regular updates from HQ on new information as it becomes available.
- SRS has been evaluating the H Canyon tunnel degradation for several years and has established a technical basis for its continued operability.
- Issues surrounding degradation and ability to perform safety related functions are very technical in nature.

NEPA Update

- DOE is evaluating disposal of GTCC LLW in a geologic repository, in intermediate depth boreholes, and in enhanced near surface disposal facilities.
- Alternative locations for these disposal facilities are: Idaho National Laboratory; Los Alamos National Laboratory, WIPP, and some area within and around WIPP referred to as WIPP Vicinity in New Mexico; Nevada National Security Site; Savannah River Site; and Hanford



NEPA Update

- DOE is also evaluating generic commercial disposal at arid and humid locations. DOE includes DOE LLW and transuranic waste having characteristics similar to GTCC LLW and which may not have an identified path to disposal (referred to as GTCClike waste) in the scope of this EIS.
- The draft EIS was issued on February 25, 2011. The Notice of Availability for the Final EIS was issued March 4, 2016. The ROD date is uncertain.
