Committee Welcome: Bob Doerr, Committee Chair Mr. Doerr welcomed everyone to the meeting.

Point of Contact Status Update: Zach Todd, DOE-SR

Zach Todd informed the Board and the public that the President has released his preliminary budget for the year and the Site should be expecting FY'18 budget by the end of April or early May. The strategic plan is still with Headquarters and they plan on meeting to discuss it. Military training is still ongoing at the Site and several units have been utilizing the Site for the past few months. The SC National Guard plans on starting a few projects at the beginning of the summer.

Mr. Todd concluded his update by answering questions form the Committee and public.

Committee Discussion

The Committee discussed Recommendation #338: Revision of the Savannah River Site Community Involvement Plan and Recommendation #342: Military Trainings at the Savannah River Site. The Committee agreed to keep Recommendation #338 until they received more information from CAB member David Hoel. Recommendation #342 DOE's response to Recommendation #342 explained that they will continue to partner with SC National Guard but all military training is controlled by the SC National Guard and it is their responsibility to inform potential users of the training venues and DOE does not directly interact with prospective military units. Zach Todd explained that the SC National Guard has reached out to other units about training at SRS. The Committee motioned to close the recommendation.

Nina Spinelli, CAB Chair presented her recommendation *Drone Spotting over SRS.* She recommended, based on SRS's sensitive material and public concern that the DOE continue to investigate drone sightings and work with authorities to restrict the airspace over SRS. CAB

members stated that the topic is relevant but had concerns over the limitations of the airspace restrictions. Michael Mikolanis suggested that the Committee request a presentation on the topic of drones. The Committee continued discussion and agreed to request a presentation. The Committee motioned to table the recommendation until more information on the topic is presented.

Nina Spinelli, CAB Chair presented her recommendation concerning disseminating information regarding controlled burns. The Committee made minor changes and agreed to move the recommendation to the Full Board.

David Vovakes, CAB Member presented his recommendation on the Strategic Plan. He recommended that SRS update their Strategic Plan so it can coincide with DOE's. CAB members asked questions concerning SRS's strategic plan and the timeline for updating it. The Committee motioned to present the recommendation to the Full Board and it was accepted.

Public Comment

There were no public comments.

Mr. Doerr adjourned the meeting.
