Meeting Summary
SRS CAB – Full Board Meeting
Columbia Metropolitan Convention Center, Columbia, SC
May 16, 2022

Meeting began at 1:00 PM Eastern Standard Time

Meeting Rules: James Tanner, CAB Facilitator

Mr. Tanner welcomed board members to Columbia, South Carolina. He said a board member requested to rite the Pledge of Allegiance. The group proceeded to rite the pledge.

Chair Update: Gregg Murray, CAB Chair

Mr. Murray welcome the group and highlighted the importance of the CAB. Mr. Murray thanked the group for showing up to the meeting. Mr. Murray gave highlights of Spring Environmental Management Site Specific Advisory Board meeting which took place in Paducah, Kentucky. Mr. Murray said it was a successful week of events in Kentucky. Mr. Charles Hilton talked about the site tour and his favorite parts of the meetings.

Site Manager Update

Mr. Budney welcomed the board members to the meeting. Mr. Budney gave remarks on the budget, contract updates, key projects, and outreach events currently going on at Savannah River Site (SRS).

Site Manager Update Q&A

Mr. Murray thanked Mr. Thomas Johnson, Deputy Manager at SRS, happy retirement. He thanks him for all of his years of service. Mr. Murray stated he was disappointed to hear a presentation from Nuclear Materials was pulled from the agenda this morning. Mr. Murray wanted to know if this would be something he should be concerned about in the future. Mr. Budney said he would not be concerned about this event. He said he received a notification to remove the item from the agenda due to an interagency group.

Mr. Hilton asked about a waste flow process with H Canyon. Mr. Hilton wanted to know what the Salt Waste Processing Facility flow level going to be. Mr. Budney said the goal is 6 million gallons a year.

Ms. Williams asked about the security contract and asked about the Wounded Warrior Hunt. Mr. Budney said the Wounded Warrior hunt was open to wounded warriors only, but other deer hunts are open to the public. Mr. Budney explained the updates for the security contract and the status of it.

Agency Updates

Jon Richards with Environmental Protection Agency gave updates on region 4 activities currently going on at the site. Mr. Richards talked about a five-year review project he is working on with SRS. Susan Fulmer with South Carolina Department of Health & Environmental Control (SCDHEC) provided updates on SCDHEC activities at SRS.

The four subcommittee chairs or selected representative each provided on update on the subcommittee.

The SRSCRO was created to promote the Savannah River site positively amongst residents and businesses and to support economic opportunity in the region.

As a result of my recent interactions with Bolin Marketing Group (BMG) Inc., I do not believe they live up to the SRSCRO's mission and I believe they create needless distraction and possible risk to SRSCRO's reputation.

I am hereby requesting the following:

- 1) Immediate investigation into BMG Inc's sales practices
- 2) Investigation of BMG's use of the SRSCRO name in its sales and any potential harm from affiliation
- 3) Recommendations to pursue alternative vendors through a formal RFP process with a an eye towards selecting those who will better represent SRSCRO as a public face

I do not believe BMG Inc. is the right partner for the SRSCRO moving forward.

Furthermore, despite having raised my concerns with SRSCRO directly, I have received no emails or calls from SRSCRO or attempts to remedy them.

In 2018 in a presentation to this very board, Rick McLeod appeared to go to some length to defend Bolin Marketing and the SRSCRO's association with BMG. How that benefited the SRSCRO or the citizens of the area I do not understand.

Continuing any business relationship with BMG is a tacit approval of their sales practices - something I would think the SRSCRO would neither support nor promote.

I am hoping my schedule will allow me to attend the CAB in person in May but if I am unable, I would be happy to join by phone or video to provide further commentary or answer questions.

May 17, 2022**

Meeting began at 9:00 AM Eastern Standard Time

Chair Update: Gregg Murray, CAB Chair

Mr. Murray welcomed back for the second day. Mr. Murray said he enjoyed a dinner last night with his CAB colleagues. He reminded the board meeting will end early due to the agenda removing a presentation. Due to that adjustment Mr. Murray said he will lead a Recommendation Writing Workshop which will be open to all board members.

Meeting Rules: James Tanner, CAB Facilitator

Mr. Tanner reviewed the agenda for the day. The order of the agenda will change slightly because a presenter was stuck in traffic.

Performance Assessment Training: Kent Rosenberger, SRMC

Kent Rosenberger from Savannah River Mission Complete (SRMC) gave a presentation on Performance Assessment training at SRS. The presentation covered the purpose of and the need for a performance assessment. Mr. Rosenberger showed model development, the performance assessments results, reviews with stakeholder involvement, and conclusions. Mr. Rosenberger answered questions on all aspects of the program.

D-Area Deactivation & Decommissioning and Cleanup Progress: Karen Adams, DOE-SR

Karen Adams with DOE-SR gave a detailed presentation on Deactivation & Decommissioning (D&D) activities in D-Area. Ms. Adams explained the definitions of Deactivation and Decommissioning for the board members to understand the process better. Ms. Adams explained the role of Savannah River Site Community Reuse Organization with D&D projects. Ms. Adams, Kelsey Holcomb Project Manager (SRNS), and Thomas Johnson (DOE-SR) answered board members questions.

Risk Reduction as a Facilitator of Tank Closure: Mike Borders, SRMC

Mike Borders with SRMC discussed the new SRMC contact at SRS. He talked about the scope of the contract with the main priorities being Project Management and Support Services plus Liquid Waste Stabilization/Disposition. In addition, SRMC will integrate SWPF into the SRS liquid waste system to maximize salt waste processing and tank closures. Mr. Borders stated SRMC wants to be transparent with everything they started with and have a clear path forward to achieve its goal. Mr. Borders and Mike Budney (DOE-SR) answered board member questions.

Public Comment

No public comments were made.



Board Business

Mr. Murray gave an overview on Recommendation 367, SRS Stakeholder Survey. The recommendation came from 2019, and DOE performed the survey in 2021. A report was emailed out to the CAB in 2022. Mr. Malik asked how DOE implemented the survey. Mr. Murray said DOE conducted the survey and received a report. Mr. Murray was happy with how the survey and found the results to be interesting. The vote passed unanimously.

Closing Remarks

Mr. Murray mentioned he was holding the recommendation writing workshop after a lunch break. He loved everyone's energy and was looking forward to the July Full Board in Augusta, GA.

Meeting adjourned at 11:25 AM EST
