Meeting Summary SRS CAB – Full Board Meeting Center for African American History, Art, & Culture Aiken, SC March 25, 2024

Meeting began at 1:00 PM Eastern Standard Time

Meeting Introduction: James Tanner, CAB Facilitator

Mr. Tanner welcomed everyone to the March Full Board meeting. He reminded those seated in the u-shape to speak directly into the microphones.

Chair Update: Phyllis Britt, CAB Chair

Ms. Britt thanked everyone for attending the meeting in downtown Aiken, SC. Ms. Britt recently attended the Waste Management Symposium in Phoenix, Arizona. She was part of a panel which included Savannah River Site (SRS) personnel and community stakeholders. Ms. Britt was thankful to have the experience and was happy to interact with people within the Environmental Management (EM) complex.

Site Manager Update

Site Manager Mike Budney provided an update on current SRS projects. Mr. Budney reviewed all current contracts, liquid waste system, Savannah River National Laboratory (SRNL), and other key projects currently happening at the site.

Site Manager Update Q&A

John Thomas asked if those individuals participating in the fishing tournament were able to take home what they caught. Mr. Budney stated the fishing events were all catch and release.

Agency Updates

Jon Richards with Environmental Protection Agency (EPA) gave an update on current EPA projects at the site. Mr. Richards introduced his coworkers who were able to attend this meeting. Susan Fulmer reviewed all current South Carolina Department of Health and Environmental Control (SC DHEC) projects.

Budget Update and Request for Priorities: Zach Todd, DOE-SR

Zach Todd, DOE-SR, presented an update on how the Department of Energy (DOE) budget operates at SRS. The presentation included an overview of the Federal Budget Planning Process, Review of Fiscal Year (FY) 2025 President's Budget Request, Review of FY 2025 Priorities, and Discuss FY 2026 Planning. Mr. Todd showed the board members the Integrated Priority letter the CAB approved in 2023. Mr. Todd, Amy Boyette (DOE-SR), and Mike Budney answered board member questions.

Board Business

Mr. Tanner reviewed the purpose of the IPL and its importance to the CAB and DOE. The board had a draft letter to review and make changes. The board discussed the importance of mission activities and agreed on an March 25, Full Board Meeting Summary



order. Hubert Van Tuyll motioned to vote on the IPL and Kenneth Sajwan seconded the motion. *The motion passes unanimously*.
